TOWN OF CHURCHBRIDGE

Altering Street Names Bylaw

A BYLAW OF THE TOWN OF CHURCHBRIDGE TO REPEAL BYLAW 7-85 and REPEAL AMENDMENTS 2017-001, 2018-005, and 2019-001.

The COUNCIL of the Town of Churchbridge, in the Province of Saskatchewan enacts as follows:

1. That an official system of naming streets and avenues in the Town of Churchbridge be established as shown on the Plan of the Town of Churchbridge attached hereto and identified as Schedule "A" to this Bylaw, together with subsequent amendments thereto as shown on the attached Plan No. 84-Y-10409, also identified as Schedule "A".
2. That the designation of certain streets and avenues in the Town of Churchbridge be altered in accordance with Schedule "B" of this bylaw.
3. Names of streets and avenues in the Town of Churchbridge shall remain as shown in Schedule "A" and "B:" of this bylaw, unless officially changed by an amending bylaw.
4. This bylaw shall come into effect on the day of the final approval thereof the Master of Titles.
5. This hereby repeals Town of Churchbridge Bylaw 7-85 A Bylaw to Alter the Street Names in the Municipality, and Bylaw Amendments 2017-001, 2018-005, and 2019-001.

1. That the name of the street commonly known as JUBILEE STREET on Plan No. 84-Y-10409 in the Town of Churchbridge, be altered and be now known as BASKEN STREET.
2. That the name of the street commonly known as LOPSTON STREET on plan numbers AB3834, 62-Y-04845 in the Town of Churchbridge, be altered and be now known as LOPTSON STREET.
3. That the name of the street commonly known as PROTHERO AVE on plan numbers 3604, 83Y01582, and 102067309 in the Town of Churchbridge, be altered and be now known as PROTHERO AVE EAST.
4. That the name of the street commonly known as PROTHERO AVE on plan numbers 66Y04845, 62Y07615, AE2466, 67Y05635, and 63Y07214 in the Town of Churchbridge, be altered and be now known as PROTHERO AVE WEST.
5. That the name of the street commonly known as VINCENT AVE on plan numbers AB3834, AB5355, and 3604 in the Town of Churchbridge, be altered and be now known as VINCENT AVE WEST.
6. That the name of the street commonly known as VINCENT AVE on plan numbers 67Y04976 and 3604 in the Town of Churchbridge, be altered and be now known as VINCENT AVE EAST.
7. That the name of the street commonly known as MAPLE CRESCENT on plan number 102117282 in the Town of Churchbridge, be altered and be now known as CEDAR CRESCENT.
8. That the name of the street commonly known as MAPLE CRESCENT on plan number 83Y01582 in the Town of Churchbridge, on the North side of PROTHERO AVENUE EAST, be altered and be now known as CEDAR CRESCENT.
9. That the name of the street commonly known as MAPLE CRESCENT on plan number 83Y01582 in the Town of Churchbridge, on the South side of PROTHERO AVENUE EAST be altered and be now known as MAPLE STREET.
10. That the name of the street commonly known as RAIKES STREET on plan numbers AE2466 and 3604 in the Town of Churchbridge, on the North side of the Trans-Canada Highway be altered and be now known as RAIKES STREET NORTH.
11. That the name of the street commonly known as RAIKES STREET on plan number 3604 in the Town of Churchbridge, on the South side of the Trans-Canada Highway be altered and be now known as RAIKES STREET SOUTH.
