# Understanding Your Tax Notice

The 2024 Mill Rate and Base Tax were approved by Council at their regular meeting on May 21, 2024. The base tax will increase from \$1080 to \$1145 and the Mill Rate will increase from 8.4 to 8.9 mills.

Early tax payments are due by June 30, 2024. Taxes paid by June 30, 2024 will receive a discount. Property taxes are due December 31, 2024. All taxes unpaid after December 31, 2024, will be subject to a 10% per annum penalty added on January 1, 2025 and applied to the total taxes that remain unpaid as of January 1, 2025.
